Introduction

The African Renaissance and Diaspora Network (ARDN) and the Permanent Mission of Senegal to the United Nations will host the 7th annual Africa Open for Business Summit on 27 September 2024, during the high-level debate of the 79th Session of the UN General Assembly (UNGA 79) in New York.

Summit Format

- A 60-minute session with 3-minute presentations by companies, foundations, and young entrepreneurs focused on concrete solutions for addressing the SDGs in Africa or supporting Agenda 2063.
- Q&A and discussion of partnership opportunities with the presenters.

Panels

- Two 30-minute panel discussion by young people, and professionals, to comment on the presentations, compare them to existing initiatives in Africa, and explore investment and replication opportunities.
- Fifteen minutes of Q&A from attendees.
